EU organic regulation (EU 848/2018) states that while mutilations which lead to stress, harm, disease or the suffering of animals are banned, specific operations essential to certain types of production and for the sake of security for animals and human beings may be permitted under restricted conditions. In addition, appropriate breeds shall be chosen and shall contribute to the prevention of any suffering, avoiding the need for the mutilation of animals.

The Livestock Management Plan as referenced in section 3 of the **Organic Food and Farming Standards in Ireland** – is contained within your Record Book and must be maintained up to date and available for inspection.

**Any suffering to the animals shall be reduced to a minimum by applying adequate anaesthesia and/or analgesia and by carrying out the operation only at the most appropriate age by qualified/competent personnel.**

Disbudding of a calf latest within <b>15 days</b> of birth (except where horns have not emerged or where calf is sick or weak). <b>ANAESTHESIA AND/OR ANALGESIA MUST BE USED</b>	
Dehorning only to be undertaken in exceptional circumstances by Veterinary Surgeon.	
Non-surgical castration of a bull no more than <b>6 months</b> of age. <b>ANAESTHESIA AND/OR ANALGESIA MUST BE USED</b>	
Castration through use of rubber ring is permitted within <b>8 days</b> of birth. <b>ANAESTHESIA AND/OR ANALGESIA MUST BE USED</b>	
<b>Restricted Practice – Sheep and Goats</b>	
Disbudding of a sheep or goat within <b>8 days</b> of birth. <b>ANAESTHESIA AND/OR ANALGESIA MUST BE USED</b>	
Non-surgical castration of a ram no more than <b>3 months</b> of age. <b>ANAESTHESIA AND/OR ANALGESIA MUST BE USED</b>	
Non-surgical castration of a goat no more than <b>2 months</b> of age. <b>ANAESTHESIA AND/OR ANALGESIA MUST BE USED</b>

<b>Restricted Practice – Pigs</b>	
Castration of a pig within <b>8 days</b> of birth by a method that does not involve tearing tissue. <b>ANAESTHESIA AND/OR ANALGESIA REQUIRED</b>	
Tail docking within <b>8 days</b> of birth. <b>ANAESTHESIA AND/OR ANALGESIA MUST BE USED</b>	
Teeth Clipping within 8 days of birth. <b>ANAESTHESIA AND/OR ANALGESIA MUST BE USED</b>	
<b>Restricted Practice – Deer</b>	
Castration through use of rubber ring is permitted within <b>8 days</b> of birth <b>ANAESTHESIA AND/OR ANALGESIA MUST BE USED</b>	
<b>NOTE:</b>	<b>The trimming of beaks in relation to poultry is not permitted.</b> <b>Clipping wings in relation to bees (queens) is prohibited.</b>

**Transportation of animals:**

Loading and unloading of animals shall be carried out without the use of electrical stimulation to coerce the animals. The use of allopathic tranquillisers, prior to or during transport, is prohibited.

**Who can carry out these operations:**

**Competent Person**

Being “competent” in relation to an operation or procedure means—

- (a) being familiar with,
- (b) having the necessary training and experience to successfully carry out,
- (c) having the technical skill to successfully carry out, and
- (d) having the requisite equipment to successfully carry out, the operation or procedure.

The operative must be the owner or person in actual possession of the animal or his or her employee acting under the direction of the owner or person; in actual possession of the animal, and that the procedure is part of, or incidental to, the normal husbandry and management of the animal.
