The current EU regulation (EU 834/2007 and 889/2008) states that you must use organic pullets wherever they are available. If suitable quantities or breeds of organic pullets are not available, permission may be granted to purchase non-organic pullets. **Please note non-organic pullets must be reared to organic feed and veterinary standards.**

If you would like permission to purchase non-organic pullets you should inform us of the following (and attach to this application):

The name and contact details of the non-organic pullet producer that you would like to use	
The documentation that they will provide to show that they have reared the non-organic pullets to organic feed and veterinary standards	
Why any organic pullets that are available are not suitable for your use	
How old are the pullets you wish to purchase	
What you are planning to do to try to make sure you can get enough organic pullets in the future	

You should use a copy of this form to request permission each time you wish to purchase non-organic pullets.
