The IOA Certified Product Scheme provides private certification for products such as composting materials, homeopathic remedies, pet food, permitted soil treatment agents and permitted feed additives, for example, calcium carbonate. These products are certified under private standards as they are all outside the scope of EU organic legislation.

VETERINARY MEDICINES

Routine veterinary inputs are not permitted – treatment can only be administered where the animal shows signs of illness.

The use of veterinary products requires justification to be available to the IOA at inspection time.

Justification can be:

- Vet letter
- Faecal Analysis
- Blood Analysis
- Soil Analysis

Withdrawal periods must be doubled in organics.

Organophosphate dips **are not allowed** in organics, products that can be used instead are:

- Clik
- Clikzin
- Ectofly pour-on (cypermethrin)
- Cyperguard (cypermethrin)
- Vector (cypermethrin)

The use of hormones **is not allowed** in organics. There may be rare exceptions for individual animals and you must ensure you contact the Irish Organic Association before using any hormone treatments.

Ivermectin based products should be avoided, all other means of veterinary intervention should be exhausted before ivermectin based product can be used.

Number of treatments permitted without a 12-month period (not including vaccine or parasite controls):

- Animals for meat production – 1 course of treatment
- Animals for breeding – 2 courses of treatment
- Dairy mastitis control – 2 courses of treatment

A course of treatment means all necessary measures taken to restore the animal to health following a particular disease.
